Age 71, Johnstown, died February 15, 2022. He was born October 11,

He was a former public defender and assistant district attorney, the former solicitor for Adams Township Zoning Authority, Adams Township Water Authority, and West Taylor Township. Gary was a former member of the Southern Alleghenies Museum of Art. He was an avid reader who loved creating and reciting limericks with his friends and enjoyed his many trips to Western Europe, where he roamed the museums and lectured to anyone who would listen. Gary liked reading by the pool, entertaining, and vacations with his family. He made friends everywhere he went – he may not remember your name, but he remembered your story. There are some who bring a light so bright to the world, that even after they are gone, it remains.
